The Paris Gibson Square Museum of Art's Annual Art Auction and Benefit Dinner is once again approaching, and we invite interested artists to submit work for juried consideration in the exhibition and sale. The auction is a premiere social event connecting museum patrons with the region's finest artists set against the backdrop of fine cuisine. The upcoming **14th Annual Art Auction and Benefit Dinner** takes place Saturday, February 5, 2011 at the Meadow Lark Country Club. Proceeds from the live and silent auctions assist the museum in continuing its community-driven mission to provide public access to contemporary art exhibitions and related educational programs.

For artists desiring to submit work for the jurors' consideration, please fill out and return the form (on reverse). Applications must be received no later than Monday, October 11, 2010. Include up to three 300 dpi digital images (jpeg format) of available work, a 50 word artist's statement, and current resume/bio on a CD (documents should be submitted in Word format). Please label jpeg files with last name, first name and number corresponding with the selection number on the form (i.e. Doe, John 1). Application materials will not be returned. Letters of notification about jury selections will be sent out Tuesday, November 30, 2010.

Also, please indicate whether you intend to donate an artwork or to split the selling cost evenly with the museum. Selected artists who choose to donate work will receive 1 complimentary ticket to the dinner and may purchase an additional ticket at cost. All other selected artists may purchase two tickets at cost. The Square reserves the right to place work in either the live or silent auction. If your work is selected for this year's auction and exhibition, you will be sent an auction agreement, which must be signed and returned with artwork by the delivery deadline Friday, December 27, 2010. To complement the 14th Annual Art Auction and Benefit Dinner, an exhibition of all art auction selections will be presented in three of The Square's main floor exhibition galleries. Exhibition dates are January 13 - February 2, 2011 with an auction preview reception Thursday, January 13, 2011. This is our opportunity to honor selected artists and showcase their work.

This year's jury process is open to all artists. Artists 17 and younger must have parental consent. Please feel free to suggest submissions to other artists. All application materials can be found on the museum's website (www.the-square.org) or may be picked up in person at the museum's reception desk.

The Square is not responsible for mislabeled images. Form, images, updated resume and artist's statement (50 words or less) are due at The Square no later than Monday, October 11, 2010. Late applications may not be considered.
